**Notice Regarding the Conclusion of a Basic Agreement Between Alfresa Corporation and
SEGA SAMMY HOLDINGS INC. Regarding the Former's Assumption of the Facilities,
Equipment, and Related Assets of the Latter's Adult Amateur Baseball Club, SEGA
SAMMY BASEBALL, and the Preparations for the Establishment and Operation of a
New Adult Amateur Baseball Club**

Subsidiary Alfresa Corporation (head office: Chiyoda-ku, Tokyo; representative director & president: Yusuke Fukujin; hereinafter “Alfresa”) has entered into a basic agreement with SEGA SAMMY HOLDINGS INC. (head office: Shinagawa-ku, Tokyo; president and group CEO, representative director: Haruki Satomi; hereinafter “SEGA SAMMY”) regarding the assumption by the Company of the facilities, equipment, and related assets of SEGA SAMMY’s adult amateur baseball club, SEGA SAMMY BASEBALL, and the preparations needed to establish and operate a new adult amateur baseball club that will join the Japan Amateur Baseball Association (JABA). The details of this agreement are as follows.

1. Background and Purpose of the Agreement

Guided by its Group philosophy of “reliability, safety, and sincerity,” the Alfresa Group contributes to community healthcare and supports people’s health through the stable supply of pharmaceuticals, which are products vital to life. The Alfresa Group believes that its human resources, who endeavor to help accomplish this mission, are the driving force of sustainable growth. Holding true to this belief, the Group has positioned securing and developing human resources and enabling them to realize their full potential as a key sustainability issue.

Meanwhile, SEGA SAMMY BASEBALL boasts an extensive track record of accomplishments, including outstanding performance in the Intercity Baseball Tournament and the National Championship of the Japan Amateur Baseball Association (JABA). The club’s history spans over 20 years, during which it has even produced professional baseball players. It has also been actively involved in events, sports classes, and other activities that contribute to the local community.

In light of the club's plan to end its activities at the end of the 2026 season, Alfresa has concluded a basic agreement with SEGA SAMMY to move forward with discussions regarding the former's assumption of the latter's club operational foundation, including players and team staff, training facilities, and team management know-how. Going forward, Alfresa will work together with relevant parties to advance preparations for establishing a new adult amateur baseball club, guided by the Group philosophy of "reliability, safety, and sincerity."

Through the sport of baseball, the Alfresa Group will foster values and a standard of conduct that espouses such virtues as sustained effort toward achieving goals, collaboration among people performing different roles, learning from failures and growing based on those lessons, discipline, initiative, teamwork, and perseverance. Simultaneously, as a corporate entity with a mission of providing a stable supply of pharmaceuticals, the Alfresa Group will forge ahead with its efforts to secure and develop its human resources and allow them to realize their full potential. Furthermore, through local residents' attendance at games and support for the team, and through the creation of opportunities to enjoy sports together with local community members and thereby foster relationships, the Group aims to unite the players, manager, coaches, and other team staff with its employees in promoting the health of local residents and vitalizing the community.

2. Outline of the Basic Agreement

Under this basic agreement, discussions will be held primarily on the following matters.

- (1) Matters related to the transfer of facilities and equipment
- (2) Matters related to the assumption of the employment of players and team staff
- (3) Matters related to the assumption of team operational know-how and other expertise
